## Town of Amsterdam, Montgomery County ASPHALT PAVING FOR TOWN ROADS

#### INTENT:

It is the intent of this bid proposal to solicit bids for materials, equipment and labor to resurface with Asphalt various roads within the limits of the Town of Amsterdam. The successful bidder will furnish all materials, labor and equipment to deliver, place and compact the asphalt as per specifications.

#### **DETAILED SPECIFICATIONS**

#### 1. MATERIALS AND WORKMANSHIP

All materials and workmanship shall comply with applicable specifications of items listed in Standard Specifications, Construction and Materials. New York State Department of Transportation Design and Construction, dated January 2, 1981, and Addenda thereto. These specifications may be modified at the discretion of the Highway Superintendent of the Town of Amsterdam.

#### 2. STREETS TO BE PAVED

The Highway Superintendent of the Town of Amsterdam shall designate the specific streets to be paved, and additional streets may be added or some streets deleted, depending on the outcome of the bidding process.

#### 3. TYPE OF ASPHALT

All applied asphalt concrete shall be New York State Department of Transportation Specification 403.13 Type 6 F Top unless otherwise specified on paving program sheet.

#### 4. PREVAILING WAGE RATE SCHEDULE

The successful bidder must comply with the current wage rate schedule and all other requirements as determined by the New York State Department of Labor. Certified Payroll Affidavits are to be submitted to the Town of Amsterdam Highway Department.

#### 5. **EQUIPMENT**

Bituminous paver shall be a self-powered unit having an activated screen assembly. The screen assembly shall be heated as necessary to produce a finished surface of the required evenness and texture without tearing, shoving or

gouging the mixture. All bituminous pavers shall be equipped with approved automatic transverse slope and longitudinal screen controls. The controls shall perate from suitable fixed or moving references. Steel wheel rollers shall be self-propelled, and an 8 to 10 ton tandem type. Exceptions to this provision must be approved by the Highway Superintendent of the Town of Amsterdam.

#### 6. **PREP WORK**

The successful bidder is responsible for cutting of all keyways prior to the successful bidder's resurfacing application.

#### 7. **BIDDING PROCEDURE**

All bidders must quote each street as a lump sum price.

#### 8. INSURANCE AND HOLD HARMLESS AGREEMENT

Upon awarding of the bid, the successful bidder must provide proof of insurance, naming the Town of Amsterdam as the additional insured, minimum \$1,000,000 liability coverage, adequate Workers' Compensation Insurance coverage. Please refer to "Insurance Requirements - Concessionaires, Contractors, and Public Entity Contracts" for complete details of what is required.

#### 9. NON-COLLUSION BIDDING CERTIFICATE

All bidders are required to sign the attached Non-Collusion Bidding Certificate.

#### 10. TRUING AND LEVELING

It is the intent that all streets in mention shall be trued and leveled with asphaltic top, as specified, using a bituminous self-powered paver as per number "5" of "Detailed Specifications". Truing and leveling material shall then be thoroughly rolled prior to each street receiving a layer 1-1/2 inches thick of Type 6 F Asphalt.

## INSURANCE REQUIREMENTS - CONCESSIONAIRES, CONTRACTORS, PUBLIC ENTITY CONTRACTS

The Contractor shall purchase and maintain during the life of the contract the following insurance. This insurance must be purchased from a New York State licensed; A.M. Best Rated "A" or "A+" carrier. The Town of Amsterdam Municipality and the Amsterdam Municipal Board, with the exception of Workers' Compensation and Employers Liability Insurance, shall be named as an additional insured. A copy of the certificate shall be mailed to the Municipality, with a provision that in the event the policies are either canceled or diminished, at least 30 days prior written notice by certified mail, return receipt requested, thereof shall be given to the Municipality. The Contractor shall not commence work under this contract until they have obtained all insurance as required and such insurance has been approved by the Municipality. The Contractor shall require any subcontractor(s) to provide all of the requirements of this section before any work is to commence. In addition, all subcontractors must carry statutory Workers' Compensation, Employers Liability and Disability Benefits Insurance for their employees.

#### I. FOR ALL COVERAGE:

Any deductibles or self-insured retentions must be declared to and approved by the Municipality. Any failure to comply with reporting provisions of the policies shall not affect coverage provided to the Municipality, its Board, officers, employees or volunteers.

#### II. COMMERCIAL GENERAL LIABILITY INSURANCE:

"Occurrence" form, including Premises-Operations, Products-Completed Operations, Contractual, Personal Injury, Owner-Contractor Protective and Fire Damage Legal Liability. Coverage shall be in the amount of \$1,000,000 per occurrence, \$2,000,000 aggregate.

#### III. COMPREHENSIVE AUTOMOBILE LIABILITY INSURANCE

On owned, hired, leased, or non-owned motor vehicles in the amount of \$1,000,000 per occurrence, Combined Single Limit. Policy should include Code 1 - "any auto" and Insurance services Office (I.S.O.) ENDORSEMENT CA 0029 (Ed. 12/88) - Changes in Business Auto and Truckers Coverage.

With regard to Comprehensive Automobile, Commercial General Liability and Optional Excess Liability coverages, the policies shall be endorsed to contain the following provisions:

• Contractor's insurance coverage shall be primary insurance as respects the Municipality, its Board, officers, employees and volunteers.
