**A RESOLUTION PROVIDING NOTICE OF NON-RENEWAL OF FIRE PROTECTION SERVICES
AGREEMENT WITH THE FORT JOHNSON FIRE DEPARTMENT**

The monthly meeting of Town of Amsterdam Board was convened in public session at the office of the Town of Amsterdam located at 283 Manny’s Corners Road, Amsterdam, New York on October 15, 2025, at 6:00 p.m., local time.

The following resolution was offered by _____, and seconded by _____, to wit:

WHEREAS, the Town of Amsterdam and the Fort Johnson Fire Department are parties to a Fire Protection Services Agreement (the “Agreement”), a copy of which is appended hereto and made part of, providing fire protection services within designated areas of the Town; and,

WHEREAS, the Agreement provides for a definite term of one (1) year, ending on December 31, 2025, in accordance with Town Law § 184(3); and,

WHEREAS, the Agreement does not automatically renew and, pursuant to Town Law § 184(4), the Town is required to provide notice of its intent not to renew; and,

WHEREAS, the Town Board of the Town of Amsterdam has determined that it will not renew the Agreement beyond its current term; and,

WHEREAS, the Town Board has consulted with various fire professionals who support this action of non-renewal; and,

WHEREAS, the Town Board has created a plan for continued fire protection services for the area the Fort Johnson Fire Department formerly served; and,

WHEREAS, the Town Board wishes to formally notify the Fort Johnson Fire Department of the expiration of the Agreement effective December 31, 2025.

NOW, THEREFORE BE IT RESOLVED:

That the Town Board of the Town of Amsterdam hereby provides formal notice that the Fire Protection Services Agreement with the Fort Johnson Fire Department shall expire on

December 31, 2025 a copy of which notice is appended hereto and made part of, and will not be renewed beyond its current term; and be it further,

RESOLVED, that the Town Supervisor is hereby authorized and directed to issue written notice of this Resolution to the Fort Johnson Fire Department; and be it further,

RESOLVED, that the Town Supervisor may execute any and all documents necessary in this matter; and,

RESOLVED, that the Town Board expresses its gratitude to the Fort Johnson Fire Department for the years of service and dedication provided to the residents of the Town of Amsterdam under this Agreement.
