**A RESOLUTION AUTHORIZING THE ENDORSEMENT OF A PROPOSED JOINT
CONSOLIDATION AGREEMENT PURSUANT TO SECTIONS 751 2(a) AND 752 OF
THE GENERAL MUNICIPAL LAW CONSOLIDATING THE EXISTING TOWN OF
AMSTERDAM WATER DISTRICTS,
TO WIT: HARROWERS WATER DISTRICT, ROUTE 30 WATER DISTRICT AND ITS
EXTENSIONS, AND WALLINS CORNERS WATER DISTRICTS INTO ONE
CONSOLIDATED WATER DISTRICT SUBJECT TO THE COMPLETION OF
PROCEEDINGS PURSUANT TO ARTICLE 17A OF THE GENERAL MUNICIPAL
LAW OF THE STATE OF NEW YORK**

WHEREAS, the Town of Amsterdam has heretofore established the following Town of Amsterdam Water Districts, to wit: Harrowers Water District, Route 30 Water Districts and its Extensions, and Wallins Corners Water District, and the said Town of Amsterdam on behalf of the existing water districts wishes to consolidate all of such areas into the Town of Amsterdam Consolidated Water District, a municipal corporation existing pursuant to the Laws of the State of New York and created pursuant to the provisions of Article 17 A of the General Municipal Law of the State of New York, and;

WHEREAS, the Town Board by and through its supervisor is desirous of endorsing and subsequently entering into the annexed proposed Joint Consolidation Agreement consolidating the existing water districts into one consolidated water district serving the following water districts: Harrowers Water District, Route 30 Water District and its Extensions, and Wallins Corners Water District; and

WHEREAS, the new Consolidated Water District will assume jurisdiction over all areas previously served by the existing water districts; and

WHEREAS, in order to consolidate the existing water districts, it is necessary that the Town of Amsterdam comply with all the provisions of Article 17A of the General Municipal Law of the State of New York.

NOW, THEREFORE, IT IS:

RESOLVED, the Town Board of the Town of Amsterdam acting on behalf of the Town of Amsterdam, Harrowers Water District, Route 30 Water District and its Extensions, and Wallins Corners Water District, hereby endorses the attached proposed Joint Consolidation Agreement; and it is further,

RESOLVED, the Town personnel and officers shall undertake the steps required under the aforesaid Article 17A of the General Municipal Law of the State of New York to comply with the provisions thereof to affect such consolidation.
