**Temporary and Political Signs valid for thirty days

PERMANENT SIGNS: \$25.00

All signs must comply with Section 22 of the Town of Amsterdam Zoning Ordinance.

VARIANCE APPLICATION: \$75.00

Please note: To apply for a variance, you must first apply for a sign permit. If the sign permit is denied, your application will be referred to our Zoning Board of Appeals for consideration. Please note that the Zoning Board of Appeals meets on the second Wednesday of each month.
